

WHEREAS, an agreement between Western Suffolk BOCES and Nassau Community College has been developed for the purpose of providing education for Western Suffolk BOCES Physical Therapy Aide students participating in Nassau Community College Physical Therapist Assistant Program;

WHEREAS, both parties believe this agreement to be in the interests of the Western Suffolk BOCES students participating;

THEREFORE, BE IT RESOLVED, that the Chief Operating Officer of Western Suffolk BOCES is hereby authorized to execute the necessary agreement. This agreement may be terminated by either party upon written notice to the other, six months in advance of the next College session. Such termination will not affect the students presently enrolled in the articulation program.
